THIS INCLUDES MORE THAN 100,000 CUSTOMIZED "C2C KIDPACKS" WHICH ARE FILLED WITH CLOTHING, SHOES, BOOKS, TOYS AND MORE. IN ORDER TO COLLECT THESE ITEMS, C2C ENGAGED COMMUNITIES IN MASSACHUSETTS, PENNSYLVANIA, AND ILLINOIS TO HOST CHILDREN'S PRODUCT DRIVES ON C2C'S BEHALF.
